Commitment to Privacy

Yee Hong Centre for Geriatric
Care respects your privacy. We
are committed to keeping your
personal health information safe
and confidential. We have a
Corporate Privacy Policy which
complies with the Personal
Health Information Protection
Act (PHIPA) and the Freedom
of Information and
Protection of Privacy
Act (FIPPA).

Why do we collect your personal health information?

We collect your personal health information (e.g. name, date of birth, address, health card number, health history) either directly from you or from the person acting on your behalf so that we can provide you with quality health care.

We may also collect your personal health information from other sources, such as one of your previous health care providers, if this information is needed by us to provide you with necessary treatment and care. The personal health information is kept only as long as it is needed.

How is your personal health information used and disclosed?

The personal health information collected is only shared with those who need to be properly informed for your care:

- » To provide resident, client and family centred care
- » To support provision of continuing care following discharge or transfer to another care facility
- » To conduct safety and quality improvement activities, including satisfaction surveys
- » To meet legal requirements as permitted by law
- » For fundraising activities organized by Yee Hong Community Wellness Foundation to improve our facilities, equipment and programs
- » To obtain payment where necessary

What are your rights and choices? You or the person acting on your behalf can:

- » Ask for access to your personal health information in your file by sending a written request to the Division/Department Head
- » Exercise your right to withdraw your consent by contacting us in writing
- » Ask us to make corrections to inaccurate or incomplete personal health information
- » Ask us not to give out your personal health information to other health care provider, unless it is required by law
- » Be told if your personal health information is stolen, lost or improperly accessed

- » 頤康基金會為改善頤康中心設備、設施、及社區活動而舉辦的籌款活動
- » 收取所需費用

你和你授權的代表有什麼權利及選擇?

- » 以書面向部門主管要求查閱自己的 個人資料
- » 以書面撤回分享個人資料的意願
- » 要求我們改正不正確或不完整的個 人健康資料
- » 在合乎法例情況下,不向其他醫療 機構披露你的個人資料
- » 若你的個人資料被遺失、盜取及不 適當查閱時,將獲頤康中心的通知
